

**RESOLUTION NO: 2013-04-25**

**A RESOLUTION ESTABLISHING FEES FOR BUSINESS LICENSES  
IN HUNTSVILLE TOWN**

**WHEREAS**, the Town of Huntsville has adopted ordinances for business licenses pursuant to authority granted by state statute, and hereby sets the following business license fees to be charged on a year to year basis;

**WHEREAS**, the business applicant shall get on the Huntsville Town Council agenda for approval or denial of the business and its compliance within the current zoning,

**WHEREAS**, upon Town Council approval, a Huntsville Town business license will be issued to the applicant in a timely manner, after the business license fee is paid,

**WHEREAS**, if the same individual has two Home Occupation businesses' within the same home, the fee for the second license will be ½ the price of the highest amount license,

**WHEREAS**, if your business is in a Commercial Zoned property the Business License fee will be a minimum of \$75.00,

**BE IT RESOLVED BY** the Huntsville Town Council that the following business license fees will be charged:

Home Office	\$36.00 (computer or office equip. only)
Piano Lessons	\$36.00

<u>COMMERCIAL BUSINESS LICENSE</u>	<u>LICENSE FEE</u>
Bakery /Convenient Store/Grocery/Foods	\$75.00
Campgrounds/Trailer Courts	\$75.00
Day Care/Pre-Schools	\$75.00
Dentist Office	\$75.00
Gasoline	\$75.00
Home Cleaning Services	\$75.00
Home Delivery	\$75.00
Lodging/Bed & Breakfast/Home Rentals	\$75.00
Yard Care/Tree Trimming	\$75.00
Restaurant/Saloon	\$100.00
Peddlers/Solicitors	\$25.00 per person

\*Fixing of Fees for all other Occupations not specified above will be determined by the type of business. \$36.00 minimum

<u>BEER &amp; LIQUOR LICENSE</u>	<u>LICENSE FEE</u>	
Class A	\$250.00	Entitles the licensee to sell beer on the premises licensed in original containers for consumption <b>Off-the-Premises</b> .
Class B	\$250.00	Entitles the licensee to sell beer <b>On-the-Premises</b> in the original containers for consumption on-the-premises and to all of the privileges granted to holder of Class A License.
Class C	\$250.00	Entitles the licensee to sell beer on draft for consumption <b>On or off-the-premises</b> and to all the privileges granted to holder of Class A and Class B License. (Draft Beer)
Club Liquor/High Pt. Alcohol	\$500.00	Entitles the licensee to sale, storage, and consumption of Alcoholic beverages (liquor, wine, heavy beer, and beer) on the premises. Applicant must meet the requirements to qualify as a Club as defined by the Utah State Liquor code.

This Resolution shall become effective immediately.
